

2021 ACCIDENT/ COVID-19 WAIVER AND RELEASE OF LIABILITY FORM

By signing this waiver, I accept this agreement and take full responsibility and give up my right to bring a court action to recover compensation for any claims made as a result of participation at this Little Village playground facility.
